2.1 This procedure applies to MTS Test in Eden Prairie.

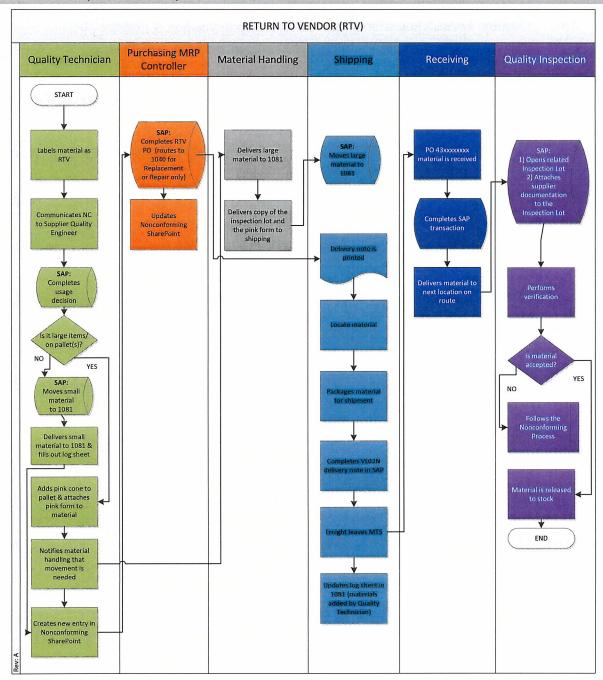

#### 5 RESPONSIBILITIES

- Ouality Technician: Marks material as return to vendor; completes physical and SAP movements for nonconforming material to location 1081 (small materials); creates new entry in NC SharePoint.
- 5.2 **Purchasing MRP Controllers**: Completes return to vendor PO in SAP; updates NC SharePoint.
- 5.3 **Material Handling**: Completes physical movement of nonconforming material to location 1081 (large materials/materials on pallets).
- 5.4 **Shipping**: Completes SAP movement of large NC material to location 1081; packages items and completes delivery note in SAP.
- 5.5 **Receiving (for Replacement or Repair)**: Completes SAP goods receipt and delivers material to Quality Inspection.
- 5.6 **Quality Inspection (for Replacement or Repair)**: Completes verification; attaches supplier documentation to inspection lot in SAP.

#### 6 PROCEDURE

#### 6.1 Quality Technician:

- 6.1.1 Adds RTV sticker to Inspection Lot printout of the NC material.
- 6.1.2 Communicates NC to Supplier Quality Engineer.
- 6.1.3 Small NC Materials:
  - 6.1.3.1 Delivers material to 1081 and fills out incoming log sheet.
  - 6.1.3.2 In SAP, completes transfer movement from nonconforming location to 1081.
- 6.1.4 Large NC materials/materials on pallets:
  - 6.1.4.1 Places pink cone on pallets and attaches pink "RTV Move Request" form to material.
  - 6.1.4.2 Notifies material handling that material needs to be moved to 1081.
- 6.1.5 In SAP, records Inspection Lot usage decision.
- 6.1.6 Creates new entry in Nonconforming SharePoint (automatic email is sent to the

Purchasing MRP Controller).

- 6.2 Material Handling *Large NC materials/materials on pallets*:
  - 6.2.1 Physically moves pallet(s) of nonconforming material to 1081.
  - 6.2.2 Delivers copy of the inspection lot and the pink "RTV Move Request" form to shipping.

#### 6.3 **Purchasing MRP Controller:**

- 6.3.1 Receives email notification from the Nonconforming SharePoint.
- 6.3.2 Processes RTV PO using Purchasing's Return to Vendor work instruction.
  - 6.3.2.1 **Rework or Repair**: Routes PO to Quality Inspection (1040).
  - 6.3.2.2 **For Credit**: Follows Purchasing's Return to Vendor work instruction.
- 6.3.3 Updates Nonconforming SharePoint.

### 6.4 **Shipping:**

- 6.4.1 For large NC materials, completes SAP movement to 1081.
- 6.4.2 Delivery note is automatically printed.
- 6.4.3 For small NC materials, locates the material per the notes on the incoming log sheet at location 1081.
- 6.4.4 Shipping "receives" the delivery by changing the appropriate date field in the delivery on SAP.
- 6.4.5 Paperwork is turned over to craters.
- 6.4.6 The crated job is turned back in to the shipping office and shipping completes VL02N Delivery Note transaction in SAP:
  - 6.4.6.1 Records dimensions and weights and Post Goods Issue information.
- 6.4.7 Booking is created or Shipping communicates to vendor that material is ready to be picked up.
- 6.4.8 Freight leaves MTS.
- 6.4.9 Delivery is posted (an invoice may or may not be created).
- 6.4.10 For small NC materials, shipping updates the log sheet by crossing off completed items.
- 6.5 Receiving (for Replacement or Repair):

- 6.5.1 Receives purchase order 43xxxxxxxx materials into the building.
- 6.5.2 Uses SAP transaction MIGO\_GR (Goods Receipt).
- 6.5.3 Paperwork (Goods Receipt or Transfer Order) is printed which indicates where the material is routed to next.
- 6.5.4 Delivers material to next location on the route.

### 6.6 Quality Inspection (for Replacement or Repair):

- 6.6.1 Part is delivered to 1040 with goods receipt and referenced 43xxxxxxxx purchase order.
- 6.6.2 Look up in QA32 by material number for related inspection lot.
- 6.6.3 Opens related inspection lot in QA12 (Maintain Inspection Lots > Change usage decision with history).
- 6.6.4 Attaches related documentation from the supplier to the related inspection lot.
- 6.6.5 Performs verification.
- 6.6.6 If it is rejected, the nonconforming process is followed.
- 6.6.7 If it is accepted material is released to stock.
